Month in Review

Equity markets rose in August. World equities rose by 0.3% in euro terms. Japan was the strongest performer - followed by Small Cap and Europe. US and Emerging Markets were the weakest performers. Materials, Health Care and Consumer Discretionary were the strongest sectors. IT, Utilities and Industrials were the weakest. Euro area bond markets declined by 0.2%.

Equity markets were boosted by indications that US interest rates would be cut in September and optimism that there may be a ceasefire in Ukraine. US corporate earnings growth for Q2 also continued to be favourable which was supportive. Euro bond markets were impacted by the political crisis in France.

CRH, Ashtead and Siemens were the best performers. Wolters Kluwer, iShares S&P 500 Information Technology Sector UCITS ETF and S&P Global were the weakest performers. Within fixed income, PIMCO Euro Income Bond Fund was the best performer and SPDR Bloomberg Barclays Euro Aggregate Bond UCITS ETF was the worst performer.
