Month in Review

Equity markets were stronger in July. World equities rose by 4.0% in euro terms. US was the strongest performer - followed by Small Cap and Asia Pacific ex Japan. Japan and Europe were the weakest performers. IT, Energy and Utilities were the best performing sectors. Health Care, Consumer Staples and Materials were the weakest. The Euro area bond index was flat in the month.

Equity markets were lifted by positive news surrounding US trade deals with the EU and Japan. Favourable US Q2 corporate earnings growth was also supportive. Euro bond markets were impacted by some better than expected Eurozone economic data and comments from ECB President Lagarde that were viewed as slightly hawkish.

Norfolk Southern, iShares S&P 500 Information Technology Sector UCITS ETF and Blackrock were the best performers. London Stock Exchange, Otis Worldwide and Wolters Kluwer were the weakest performers. Within fixed income, Bluebay Investment Grade Bond Fund was the best performer and BlueBay Investment Grade Euro Government Bond Fund was the worst performer.

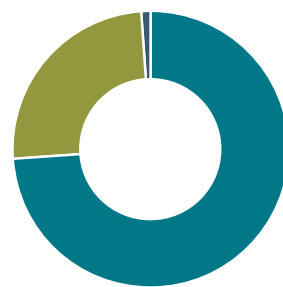
Regional Allocation as at 31 July 2025
